FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevation view thereof, the left, right and rear elevation views being identical;


FIG. 5 is a top plan view of a pizza crust, according to a second embodiment of the invention; and,

FIG. 6 is a bottom view thereof.

The front, rear, left and right elevation views of a pizza crust according to a second embodiment are identical to FIG. 4 and are omitted.

The broken lines are included for the purpose of illustrating environmental structure and form no part of the claimed design.












